

Coaches Agreement

I understand that if accepted by TCSA for any position, I am responsible for:

1. Completing all mandatory Training and Certifications,
2. Signing the TCSA Code of Conduct,
3. Attending regularly scheduled meetings,
4. Communicating with the my team regarding game/practice schedules and TCSA events,
5. Supporting all TCSA activities such as opening/closing day ceremonies, clinics, etc.,
6. Setting an example in my dealings with parents, players, Umpires, Coaches (this includes TCSA inter-league cities) and other TCSA members, as I am a role model and I shall maintain a positive image for my league.

I have read, understand, and agree to abide by the rules and regulations as set forth by TCSA and ASA, as applicable.

I understand that any false information, omissions or misrepresentations of facts called for in this application, whether on this document or not, may result in rejection of my application or discharge at any time during my tenure as a TCSA Coach, Volunteer, Umpire and/or Board member.

Coaches Code of Conduct

As a Head Coach/Assistant Coach, do hereby agree to the following Coaches Code of Conduct to insure a positive environment for all youth and adult members of TCSA:

1. I will promote good sportsmanship through leading by example and being supportive of all TCSA participants, coaches, league and game officials at all games and practices.
2. I will not personally address game officials unless done so in an official protest as stated in the ASA/Ground Rules.
3. I will not address any TCSA spectators or parents on opposing teams.
4. I will address any concerns privately with my player's parent, league officials, and TCSA Directors. Not in an open forum involving the children.
5. I will refrain from making negative statements or using profanity at all TCSA activities and facilities.
6. I will ask my players to treat all participants, coaches, spectators, league and game officials in a good sportsmanlike and respectful manner, regardless of race, sex, creed or ability.
7. I will (in conjunction with TCSA) promote a drug, tobacco and alcohol free environment by refraining from their use at organization activities and facilities.
8. I will place the emotional and physical well being of my players ahead of any personal desire to win.
9. I will be responsible for all equipment assigned to me by TCSA.
10. I will agree to abide by all TCSA Bylaws, and Ground Rules, as well all ASA rules.

I have read and understand the above statements and I agree to follow them to the best of my abilities with the understanding that any violation of this contract may result in disciplinary action that will be documented and handled by: (not limited to but may include) The Colony Police Department, and/or an appointed TCSA Coaches/Players Committee. Depending on the nature of the violation, one (1) or more of the following penalties may be given:

1. A written reprimand or warning.
2. One (1) game suspension or more, which is dependent on the infraction.
3. Season Suspension.
4. Permanent removal from coaching with TCSA.

Background Check

All Coaches in TCSA will have to complete a background check. This will be at the Coaches/Assistant Coaches own expense.

All Coaches/Assistant Coaches/dugout parents/or anyone that wants to go on the field for practice or games, must complete and pass this background check.

Once registration is over, the Coaches Agent for TCSA will send out all of the information that you will need to get this completed.

In the event that a background check is either not completed OR not passed, then that applicant WILL NOT be allowed on the field at anytime.
