## PARENTAL CONSENT RELEASE AND WAIVER OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT

FOR GOOD AND VALUABLE CONSIDERATION, including permission for \_\_\_\_\_ (the "minor") to participate in

I, the parent/guardian of the minor, for myself and on behalf of the minor:

1. Consent to the minor's participating in the event or activity;
2. Agree that prior to the minor's participation in the event or activity, the minor and I will inspect the facilities, equipment, and areas where the event or activity is being conducted. If either of us believes any of them are unsafe, I will immediately advise the person supervising the event, activity, facility, or area;
3. Acknowledge that the minor and I fully understand that the minor's participation may involve risk of serious injury or death, including economic losses, which may result not only from the minor's own actions, inactions or negligence, but also from the actions, inactions, or negligence of others, the condition of the facilities, equipment, or areas where the event or activity is being conducted, the rules of play or this type of event or activity;
4. Release, waive, discharge, and relinquish the City of Long Beach, and its event and/or activity Permittees and/or Sponsors and their officers, employees, and agents from any liability, loss, damage, claim, demand, or cause of action against them, attributable to the minor's participation in the event or activity, whether same shall arise by their negligence or otherwise.
5. Assume any and all risks of personal injuries to the minor and authorize the City of Long Beach and/or the event and/or activity Permittees/sponsors to contact or employ a licensed physician to render any medical treatment that may be deemed necessary for the minor or to take and admit the minor to any hospital. I agree to pay all medical and hospital bills relating to such medical treatment or hospitalization, as well as any expenses incurred due to permanent or partial disability, death, or damages to the minor's or my property, caused by or arising from the minor's participation in the event or activity;
6. Covenant not to sue or present any claim for personal injury, property damage, or wrongful death for or on behalf of the minor against the event and/or activity Permittees/Sponsors, the City of Long Beach, or their officers, employees, and agents, attributable to the minor's participation in the event or activity;
7. Agree that photographs, pictures, slides, movies, or videos of the minor may be taken in connection with the minor's participation in the event or activity without compensation from the event and/or activity Permittees/Sponsors or the City of Long Beach and consent to the use of the photographs, pictures, slides, movies, or videos for any legal purpose;
8. FOR MINORS PARTICIPATING IN DAY CAMPS, YOUTH SPORTS, EXTENDED DAY, AND SWIMMING LESSONS: Warrant that the minor is in good health and has no physical condition that would prevent the minor from participation in the event or activity. If the minor does have any restrictions that would prevent the minor from participation in the event or activity, warrant that a "Physical Examination Report" is on file with the City of Long Beach, for review by the City Health Officer;
9. Acknowledge and agree that the City of Long Beach, its officials, employees, and agents shall not be responsible for administering, providing, or assisting in administering medication to or medical assistance of the minor;
10. Acknowledge that the City of Long Beach and event and/or activity Permittees/Sponsors are not joint sponsors, joint venturers, partners, or otherwise jointly engaged in the above-named event or activity.

# Minor Participant Waiver, Release, Indemnification of All Claims & Covenant Not to Sue

### Warning & Disclaimer

Coronavirus disease 2019 (COVID-19) is an **extremely contagious** virus that spreads easily through person-to-person contact. executors, administrators and assigns may have, now or in the future, against The City of Long Beach Parks, Recreation & Marine on account of personal injury, property damage, death or accident of any kind, arising out of or in any way related to the use of The City of Long Beach Parks, Recreation & Marine facilities/equipment or participation in The City of Long Beach Parks, Recreation & Marine programs whether that participation is supervised or unsupervised, however the injury or damage occurs, including, but not limited to the negligence of Releasees.

In consideration of the named minor's participation in Camp Program, I, the undersigned parent/guardian of the named minor, agree to INDEMNIFY AND HOLD HARMLESS Releasees from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of or in any way related to the named minor's Camp Program participation.

I hereby certify on behalf of myself and the named minor that I have full knowledge of the nature and extent of the risks inherent in Camp Program participation and that I, on behalf of myself and the named minor, am voluntarily assuming said risks. I understand that I and the named minor will be solely responsible for any loss or damage, including personal injury, property damage, or death, the named minor sustains while participating in Camp Program and that by signing this agreement I, on behalf of myself and the named minor, HEREBY RELEASE Releasees of all liability for such loss, damage, or death. I further certify that the named minor is in good health and has no conditions or impairments which would preclude his/her safe participation in Camp Program.
