Warning & Disclaimer

Waiver, Release, Indemnification & Covenant Not to Sue

In consideration of my participation in The City of Long Beach Parks, Recreation & Marine Recreation Adult Sports Program I, _____, agree to release on behalf of myself, my heirs, representatives, executors, administrators, and assigns, HEREBY DO RELEASE The City of Long Beach Parks, Recreation & Marine, its officers, directors, employees, volunteers, agents, representatives and insurers (“Releasees”) from any causes of action, claims, or demands of any nature whatsoever including, but in no way limited to, claims of negligence, which I, my heirs, representatives,

executors, administrators and assigns may have, now or in the future, against The City of Long Beach Parks, Recreation & Marine on account of personal injury, property damage, death or accident of any kind, arising out of or in any way related to the use of The City of Long Beach Parks, Recreation & Marine facilities/equipment or participation in The City of Long Beach Parks, Recreation & Marine programs whether that participation is supervised or unsupervised, however the injury or damage occurs, including, but not limited to the negligence of Releasees.

In consideration of my participation in the Adult Sports Program, I, the undersigned, agree to INDEMNIFY AND HOLD HARMLESS Releasees from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of or in any way related to my Adult Sports Program participation.

I hereby certify on behalf of myself that I have full knowledge of the nature and extent of the risks inherent in the Adult Sports Program participation and that I, am voluntarily assuming said risks. I understand that I will be solely responsible for any loss or damage, including personal injury, property damage, or death, that I sustain while participating in the Adult Sports Program(s) and that by signing this agreement I, HEREBY RELEASE Releasees of all liability for such loss, damage, or death. I further certify that I am in good health and have no conditions or impairments which would preclude my safe participation in the Adult Sports Program.
