Adult Softball Manager's Agreement

- As the Manager, I understand that I am responsible for all the rules and regulations outlined in the Adult Softball Rules and Regulations Handbook.
- As the Manager, I understand that it is my responsibility to enforce and ensure all my players adhere to the rules and regulations outlined in the Adult Softball Rules and Regulations Handbook.
- As the Manager, I understand that I am the spokesperson for my team. All correspondence to Parks and Recreation staff must be handled through me starting with the Field Supervisor.
- As the Manager, I understand that I am responsible for the conduct of my players before, during and after league games. I also understand that my players may be suspended for unsportsmanlike conduct at any time.
- As the Manager, I understand that it is my responsibility to turn in a complete and signed roster by the start of the first league game **of each season**. I further understand that without a signed roster at the start of the first league game, my team will not be allowed to play and will forfeit all games until a team roster is turned in. This roster includes the informed consent informational waiver for COVID-19.
- As the Manager, I understand that rosters are limited to 18 players for Men's and 20 players for Coed; but I may ADD and DROP players with NO FEE up to 5 minutes prior to the start of the league game. However, NO roster changes are allowed after the 5th week of the season.
- As the Manager, I understand that Parks and Recreation staff will do their best to schedule make-up games; however, make-ups are not always possible, and my team will **NOT** receive a credit/refund for cancelled game(s).
- As the Manager, I understand that I **MUST** notify Parks and Recreation staff as well as the opposing manager in advance per the Rule Book, if I need my team to forfeit a game. Furthermore, I understand that if my team forfeits two games in a season without giving notice, my team will be dropped from the league and fees will not be refunded.
- As the Manager, I understand that if my team is caught using an illegal bat (as determined by the Umpire); the batter will be declared out, the ball declared dead, and the game instantly forfeited on behalf of the offender's team. In addition, I understand that if my team is caught a second time in a season using an illegal bat, my team will be dropped from the league and fees will not be refunded.
- As the Manager, I understand that ONE new ball per field per night will be provided. If a backup ball is needed, the umpire will use the next best available ball. I further understand that a 12-inch ball for men's / 11-inch for females, will be used for ALL games.
- As the Manager, I understand that alcoholic beverages may NOT be consumed in the park premises prior to, during, or after any scheduled games -- the game will be forfeited by the team observed consuming alcoholic beverages. I also understand that a second offense results in the team being dropped from the league and fees will not be refund. In addition, I understand that tobacco products may NOT be used in the dug-out or on the field during game time.
- As the Manager, I understand that a regulation game will last 1 hour and 5 minutes; no new innings will start after one hour of game play.
- As the Manager, I understand Parks and Recreation furnishes one game official and discussion of any game or official's decisions is made with team managers only. I further understand that scorekeepers are NOT provided; therefore, the umpire will use a flip score to keep track of runs scored. In addition, I understand that the home team will agree to keep score and fill out the score card as well as monitor line-up sheets.
- As the manager, I understand that there may be extra COVID-19 protocols and requirements in place, and I understand that it is my responsibility to enforce and ensure all my players adhere to the rules and regulations provided. Failure to comply may result in forfeit of wins and / or registration fee.

SLO Parks & Rec Return to Play During COVID-19
Adult Sports 2024 (subject to change)

Adult sports include varied activities that have different levels of risk for transmission of COVID-19. Outdoor activities present significantly lower risk of transmission relative to comparative indoor activities, based on current scientific evidence. Competition between different teams also increases mixing across groups and outside of communities, which also contributes to the potential for spread of COVID-19 disease.

- SLO Parks & Recreation will monitor and adhere to all CDC and County Health Guidelines regarding Adult Softball Play and update as needed.
- Updated specific requirements, including area sanitization, ball sanitization between games, no-contact requirements, spectator attendance, will be provided prior to the Manager's Meeting.
- Managers understand team will adhere to all Return to Play Protocols, failure to do so may result in league expulsion and forfeit of registration fee.
- Wash hands thoroughly before and after training/games.
- Wash & sanitize training equipment after every training/game.
- No loitering in dugouts after a game – please clear dugouts immediately to allow for sanitization and the next team to enter safely.
- No sharing of drink bottles and other personal items and equipment
- Respect and practice social distancing.
- Place equipment, bags, etc. at least 6 feet apart.
- No high fives, handshakes, knuckles, or group celebrations permitted.
- No one with symptoms of COVID-19 or who is in isolation or quarantine for COVID-19 is permitted to attend practices or games. Anyone with symptoms of COVID-19 should consult their physician for testing and notify their manager of their symptoms and test results.

Health / Illness

- An adult cannot attend the program with a fever, vomiting, excessive coughing, sneezing, communicable diseases, or diarrhea. An adult may not attend the program if they have symptoms of COVID-19 (listed below).

Potential COVID-19 Symptoms

- Fever • Cough • Shortness of breath or difficulty breathing • Chills • Repeated shaking with chills • Fatigue
Muscle pain • Headache • Sore throat • Congestion or runny nose • Nausea or vomiting • Diarrhea • New loss of taste or smell.

Possibility of COVID-19 Exposure

In the chance that a participant or staff member encounters, or tests positive for COVID19, the City will defer to County Public Health as to recommended steps of action. This will include manager notification, sanitization, and potential suspension of program. In the case of exposure or positivity, names will remain confidential, and all individuals will be treated with dignity.
