

## **LYB Board Meeting – 09/25/2025**

### **1. Board Position Recap/Applications**

- a. The roles of the board and commissioners were discussed in detail of what their responsibilities and expectations are.
  - i. Player Agent – aids in the tryout/draft process. Ensures all athletes get a fair chance, including but not limited to: playing time, selection, tryout time, etc.
  - ii. Vice President – the right hand to the president. Helps in fielding questions, complaints, conflict resolution, etc.
  - iii. Secretary – ensures the league is ran smoothly from an administrative point of view. Sets up training for logistical topics for coaches, including scoring applications.
  - iv. Basketball University – provides training for both players and coaches in the sport of basketball. Expected to provide practice plans, drills, attend practices for assistance, etc. A ready resource for coaches and players alike.
  - v. Commissioners – one per age division. Aids in communication of announcements, fielding questions. Expected to have a group communication with the coaches in the age division to be a resource for questions, collaboration, etc.
- b. Applications are due by Oct. 1 to Bri.

### **2. Rule Change Suggestions – Applicable for 26/27 season.**

- a. Addition of clear-cut specifications regarding colored wrist bands for 5u and 7u age divisions.
  - i. Specify that matching colors can only guard one another.
- b. Consideration for minimum playing time for players in second quarter?
  - i. Soft change: Now that we have commissioners and board members, these roles can aid in encouragement to coaches regarding playing time, instead of adding another rule.
- c. Number of saves:
  - i. Options considered: Reduce the number, do away completely, only if they've played in league before, leave alone, increase.
  - ii. Members instructed to conduct research regarding what other leagues do and evaluate what our goal is as a league to make an informed decision. Research to be brought to next board meeting on October 23.
  - iii. Decision deadline: June 1.
  - iv. Conversations and collaborations to be conducted in future meetings.
- d. At the draft – set the precedent that there will be no “gentlemen’s agreements” in regards to players. No trading hat picks.
- e. Tournaments:
  - i. Suggested to have more teams in EOS tournament for 9u-13u. We’re at LISD mercy, and cannot allow anymore due to time constraints.
- f. Aiming to condense season – less breaks!

- i. Reaching out to churches, Cedar Park Rec Center, private school courts to see if we can rent on some of the off weekends we're forced to take due to LISD.
