5. Approve Minutes:

There was a motion by Amber Hawley with a second by Vanessa Garibay to approve the December regular meeting minutes. This was board approved.

- 6. Financial Update: Chris Annicella- a more thorough financial update was sent via email
 - a. CD is due in 3 weeks. There is currently \$1600 in the account.
 - b. Chris suggested the board consider the lower registration numbers in the budget.
 - c. No current spending, but a big expense is coming when we purchase uniforms.
 - d. The biggest sources for income are sponsorships and the snack bar. A couple volunteers from the current board are going to help call old sponsors for a recommitment. Gathering new sponsors would take going to businesses and handing out a form.
 - e. LLL will donate \$1000 to each local high school baseball program. The board took a vote. This was board approved.

7. Franchise Updates:

- a. The Franchise Committee is waiting on final registration numbers to set age group limits for each team on Franchise framework. Then the framework will be complete.
- b. With James' change in schedule, Patrick will take over heading the committee.
- c. Kaushal plans to send an email to managers describing interview process, franchise process, and disciplinary steps and actions which Kyle is finalizing.
