I understand that the very nature of the game of softball is hazardous and risky, including, but not limited to, the acts of pitching, throwing, fielding and catching of the ball, the swinging of the bat, running, jumping, stretching, sliding, diving and collisions with other players and with stationary objects, all of which can cause serious injury or death to me and to other players.

Further, I agree that in consideration for right to play as a member of the team designated on this roster and in consideration for permission to play on the field arranged for by the team or league.

1. I voluntarily elect or accept and solely assume all risk of injury incurred or suffered by me (a) while practicing or playing as a member of the team so designated (b) while serving in a non-playing capacity as a team member during practice or play by other teams or by other players on my team and (c) while on or upon the premises of any and all facilities arranged for by my team or league for practice or play.

2. I release, discharge and agree not to sue the team and/or league designated on this form or any owner or other entity of facilities, the Amateur Softball Association of America, on/in which the league plays or practices by my team or league, or their owners, officers, umpires, agents, servants, associations, employees, or any person or entity connected with the team, league, facility, Amateur Softball Association of America or City of Holland, Holland Charter Township, Recreation Division for any claim, damages, cost or cause of action which I have or may in the future have as a result of injuries or damages sustained or incurred by me from whatever cause including, but not limited to the negligence, breach of contract or wrongful conduct of these parties hereby released.


