A. Tournament for Community Engagement



Alex Aguilar proposed a for the 405 FC to sponsor a tournament this coming fall. be organized to promote the 405 FC within the community. The tournament would enhance community awareness for the FC and provide a positive community event for youth and adults.

Ryan Hill commented that this is an idea to consider but will it need to be sanctioned.
