

PLAYER CODE OF CONDUCT

ADULT SPORTS



Roseville Adult Sports believes that all participants have the right to be involved in the spirit of recreation, safety and fun. The Player Code of Conduct is strictly enforced.

ACKNOWLEDGMENT OF UNDERSTANDING

- Any participant suspended will be suspended from all Adult Sports play. During the time the case is being reviewed by the League Director and a review committee, the player will remain in suspension. Any games missed while a decision is being made will count towards the number of games served to complete the suspension period. The player may return to play once the suspension has expired.
- All participants have the right to file an appeal on suspensions of three (3) games or more with the League Director. **Suspensions of two (2) games or less cannot be appealed.** The League Director may appoint an Eligibility and Reinstatement Committee to hear the appeal. Individuals violating more than one code infraction can be assessed a combination of all.
- Participants violating the Player Code of Conduct while on probation will result in a minimum of one (1) calendar year suspension from all Roseville Adult Sports activities.
- Any ejected participant must leave the gym/field/facility immediately. Failure to do so can result in a forfeiture of the game by the ejected player's team and the suspension of said player for the remainder of the season or a minimum of four weeks. If the ejected player refuses to leave the premises, the police will be called and the ejected player's team will suffer an automatic team forfeiture of the game. **The Manager and/or Acting Manager is subject to ejection and suspension as issued to the ejected player on their team.**
- All ejected players will receive a minimum one (1) game suspension.
- The League Director has the right to make any adjustments to the Player Code of Conduct at anytime for the betterment of the Adult Sports programs.

PLAYER CODE OF CONDUCT

PLAYER MISCONDUCT GUIDELINES



PHYSICAL & VERBAL ABUSE:

No player shall, at anytime lay a hand upon, shove, strike or threaten an official or staff member. Officials are required to immediately eject the player from further play and report the player to the League Director.

Minimum Penalty Immediate ejection from the game and suspension from two league games and placed on probation.

Maximum Penalty Banned indefinitely from Roseville leagues and/or charges filed.

ABIDING BY OFFICIAL'S RULING:

No player shall refuse to abide by an official's decision. Officials are required to immediately eject the player from the game and report player to the League Director.

Minimum Penalty Immediate suspension and ejection and placed on probation.

Maximum Penalty Suspension from two league games and probation.

OBJECTIONS TO OFFICIAL'S RULING:

No player shall show objectionable demonstrations of dissent of an official's decision or discuss an official's decision unless said player is the team captain or assistant captain.

Minimum Penalty Warning by official.

Maximum Penalty Ejection from the game and considered for suspension and/or probation.

CONDUCT DURING PLAY:

No player shall use unnecessary rough tactics or verbally abuse or physically attack an opposing player, official or spectator before, during or after play.

Minimum Penalty Ejection from the game and considered for suspension and/or probation.

Maximum Penalty Banned indefinitely from Roseville leagues and/or charges filed.

UNCONTROLLED SUBSTANCES:

No player shall appear on the field of play intoxicated or under the influence of any uncontrolled substance or consume alcohol before, during or after the game.

Minimum Penalty Suspension from two league games and placed on probation.

Maximum Penalty Suspension for up to one (1) calendar year and placed on probation.

FALSIFYING ROSTER INFORMATION:

No player shall play under another individual's name or falsify name, address or age on an official roster form.

Minimum Penalty Suspension from two league games.

Maximum Penalty Suspension for up to one (1) calendar year and placed on probation.

ELIGIBILITY:

No players shall play on more than one team in the same league.

Minimum Penalty Warning by League Director and placed on probation.

Maximum Penalty Suspension for the remainder of the season.

OUTSTANDING DEBT WITH PARKS AND RECREATION:

No player shall participate in any Roseville program with a financial debt outstanding to the Parks and Recreation Department.

Minimum Penalty Suspension from all Roseville programs until debt is cleared.

Maximum Penalty Suspension from all Roseville programs until debt is cleared.
