Payment of League Fees Policy

Full payment for all league fees is due upon turning in registration paperwork unless approved by the Recreation Supervisor. All league fees must be paid in full before the first night of the league.

Further, if any of my checks or Credit/Debit transactions are returned from the bank, I understand me and my team will be unable to participate in the league, visit any park district facilities, and register for any future Park District Programs/Events until the amount owed including the service fee is paid in full. Any returned checks are subject to a \$25 fee or the current posted rate.

In the event your account is past due, it may be turned over to a collection agency. If this account is not paid in full and is turned over to a collection agency and/or attorney, then you agree to be responsible for all reasonable fees necessary for the collection of the delinquent account including, but not limited to, collection agency fees of 50% of the balance due and costs and reasonable attorney's fee of 33% of the balance. You may prepay this balance due at any time before maturity. If you do, you shall receive a prorated refund credit of the processing fee thereon for that prepayment. Dropping out of the league shall not relieve payer or team of the obligation to make full payment of the program fees or require the Park District to issue a refund.

However, participants and parents/guardians of minors registering for this program must recognize that there is an inherent risk of injury when choosing to participate in recreational programs/activities.

You are solely responsible for determining if you or your minor child/ward are physically fit and/or adequately skilled for the activities contemplated by this agreement. It is always advisable, especially if the participant is pregnant, disabled in any way or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity.

2. WARNING OF RISK

Basketball is intended to challenge and engage the physical, mental and emotional resources of each participant. Despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury. All hazards and dangers cannot be foreseen. Certain risks include, but not limited to, collisions between players and stationary objects, inability to stop one's momentum and encountering off court dangers/hazards, unnecessary roughness (elbowing, hip checks, undercutting other players in the air, tripping and shoving), slip and falls, attempting a maneuver beyond the player's skill level (i.e. attempting a dunk), poor officiating, improper personal protective equipment, slippery floors, inadequate or unsafe playing conditions, failure in supervision, unsportsmanlike conduct, dangerous/defective court conditions, and all other circumstances inherent to sport of basketball. In this regard, it is impossible for the Decatur Park District to guarantee absolute safety.

ROTARY PARK FALL LEAGUES SCHEDULES

Cup in Hand Kickball (Coed) - 21+ only

Run the bases with a cold beverage! Coed games consist of 8 games plus an end of the season tournament. Games will be 6 innings with up to 12 players on each team, 21+. Equipment will be provided; all beverages must be purchased from the Decatur Park District. Alternate male/female batters. Teams' must may play with two more male players then females. (7 males and 5 females, 6 males and 4 females). Minimum of 4 females on the field at a time.

Coed Softball

Off-Hand League – All male batters must bat with their non-dominant hand. May play with 6 males and 4 females. Each team much have a minimum of 4 female players. Teams playing with 5 males and 5 females must have 1 male/1 female at catcher/pitcher, 2 females / 2 males in the infield (at any position), 2 females/2 males in the outfield (at any position). Teams playing with 6 males and 4 females must have 1 male/1 female at catcher/pitcher, 2 females / 2 males in the infield (at any position), 1 female/3 males in the outfield (at any position). Teams playing 6/4 may not play 3 male infielders.
