- 1. Call to order by President Dick LeMoine at 7:30 AM Introductions of all officers and board members were made by President LeMoine.
- 2. - 3. Minutes: The minutes of the December 7, 2016 Board meeting were approved with a minor change of the Date of the General Membership meeting which will be February 11, 2016 and not January 10, 2016. Motion by Jim Wille, second by Lloyd Styrwoll. Passed unanimously.

# Billboards/Banners & Sponsors - Ron Eppley

Ron reported that Lexus did not renew so we are looking for a new billboard sponsor. All Team sponsors are in place.

President Dick LeMoine added that VW Peoria has donated a new VW Jetta to be raffled off for the Tin Cup and suggested that the Board visit the dealership and tour their new facility in a display of appreciation for their sponsorship. The Board was in general agreement.

**Field Maintenance**: Ken Skinner had nothing new, but renewed his request for a new computer to be placed in the club house. The motion to allow Ken to purchase a computer, not to exceed \$500 was made by Lloyd Styrwoll and seconded by Marcel Mantha and passed unanimously.

**Special Event:** President Dick LeMoine appointed Ken Skinner as Special Events Coordinator with Bob Luther and Carol Bowden as his assistants. Ken commented that the Calendar of Events is full;

**Food & Beverage Committee** – Jack commented that things were going well and that they would be serving food at the Women's Tournament this weekend (January 9, 2016)

**American League Committee**: Bob Peck shared that draft was occurring that day (January 4, 2016) and they had a 120 players with 120 needed. There will be 12 teams with 10 on a team. Bob reported the following rule changes:

- 1) The Flip Flop rule would go from 7 to 5 runs.
- 2) The Mercy rule would Change to 12 runs after 5 innings and 10 runs after 6 innings.
- 3) Runs allowed per inning would go from 5 to 4. All changes were made to speed up the game. Bob said that he would report to the Board and that Orie McDonald would handle the Data Base.

President LeMoine officially appointed Bob Peck the American League chair.

<u>Central League Committee</u>: Ted DeCampo reported that the Central League Draft would be on January 6, 2016. Ted reported that at this time he had 155 players available for the draft and a need for 154 players. The Central League would have 14 teams with 11 on a team. Ted mentioned that a number of players were in flux and that there were also a number coming in from the green team.

President LeMoine commented for all league committees that rule changes needed to come through the board.

National League Committee: Barb Wadell in reporting for the National League said that there were 11 teams of 11-12 players with ability to go up to 13 if necessary. Barb reported that 24 National Leaguers took part in the One Pitch tournament. The National League was concerned about some rerating issues and this was discussed. There is also concern about getting the rights to the database transferred. President LeMoine said he would take care of this transfer.

**Women's League**: Carol Bowden was not present – no report

# 7. NEW BUSINESS:

President LeMoine read correspondence from a member who requested that each of the Leagues conduct an informational meeting for members. President LeMoine asked the League chairs to do this and to report back to him. President LeMoine read a correspondence from a member asking for base anchors to be installed at the 70 foot mark. The correspondent said that he would have the anchors made and would install them but would need up to \$250 to pay for materials. After some discussion, the motion to allow within the limits of \$250 made by Styrwoll and seconded by McFarland. Motion passed with one dissension.

President LeMoine commented that League Committees members could only be appointed for the length of service of the board but would continue to be reappointed if both parties agreed.

Ray Early requested that the Board consider purchasing a new score board that was a baseball score board and displayed the game by innings. The cost of such a score board would be 20- 25 thousand. President LeMoine commented that the present clock was purchased because of the large numerals and the time and temperature features.

The following motion was made by Larry Reed and seconded and John McFarland

Replace the "Placement list" with a "Waiting list" in all leagues. The "Waiting list" would be for only new players and would offer no guarantee of placement on a team. After receiving a rating from green team participation, new players would pay no fees and be placed on the "Waiting list" The "Waiting list" will show the player's name, rating, and date of placement on the list. When a team roster opening becomes available, the player with the rating needed by the team and the longest tenure on the "waiting list" will be offered the opening. If the player accepts the offer, fees will be paid at that time. New players may elect to pay membership fees and be placed on the "Sub list".

In addition, I further move that the "Sub list" contain names and ratings of club members who want to only play as a sub in addition to those players who want to be placed on a team. Players wanting to be placed on a team will be appropriately identified. Players on the sub list wanting to be placed on a team will receive preference over "waiting list" players.

This motioned was approved unanimously.

President LeMoine adjourned the meeting at 8:58 AM.

<u>Central League Committee</u>: Ted DeCampo reported that the Central League was functioning well. Ted reported that with 7 games being played a day that the last game in Sun City on Thursdays was ending around 4:35 PM. Ted also indicated that he has been working with the National League to develop a plan to better balance the Leagues. Ted also indicated that with President LeMoine's approval, Dan Burke was added to the Central League Committee.

<u>National League Committee</u>: Barb Wadell reported that the current session is underway with no problems. The National League has instituted the following new rules:

- **A.** Alternate pitching screen is located 15 feet directly in front of the nearest plate to be used by those pitchers who wanted to pitch over a screen they are using for protection.
- **B.** Those pitchers using the screen to the side of them are required to step behind the screen after releasing the ball. "Ball" will be called if the pitcher fails to comply. If pitcher releases the ball and does not step behind the screen but is not involved in the batted ball, the play is "live".

Pitching screen edge is to be placed at the edge of the pitching plate on side which allows pitcher to step behind the screen after releasing the ball.

- **C.** Batted ball that hits the screen is a dead ball, no strike is called.
- **D.** Mercy rule is now 10 runs after 5 innings.

A motion to accept the National League Rule changes was made by Lloyd Styrwoll and seconded by John McFarland and passed unanimously.

**70's League**: no report

**Coed League**: Barb Wadell had some concerns about the number of individuals who were gone from COED play to participate in tournaments. John McFarland reassured her that this would not be an ongoing problem.

# SUN CITY WEST GENERAL MEMBERSHIP MEETING MINUTES THE LECTURE HALL R.H. JOHNSON THURSDAY, FEBRUARY 11, 2016

The meeting was called to order by President Dick LeMoine at 6:30 PM. President LeMoine introduced the members of the board.

President LeMoine determined that with 85 members registered at the door that the quorum requirement was met. All Board members were present.

**TREASURE'S REPORT** The Treasure's report was given by Lyle Bakken (please see attachment). A motion to approve the Treasure's report was made by Richard Moschel and seconded by Craig Hone, and the motion passed unanimously.

Approval of the Minutes of the February 1, 2016, Board meeting are posted, and approval of those minutes were deferred to the March Board meeting.

# **BILLBOARDS. BANNERS & TEAM SPONSORS** – RON EPPLEY

Five billboard spaces are available for renewal. Arrowhead Lexus did not renew, but Arrowhead Cadillac appears to be positioned to take that space.

We had 24 Banners last year, and it was decided to increase that number by 10. At this time, there are five new banners and 5 to go.

In terms of team sponsorships, we have 13 Sun City sponsors and 25 Sun City West sponsors, which reflects the 1/3 - 2/3 make up of the communities participation. There is presently one unused sponsor (Sun City Tire) from Sun City.

# **70's LEAGUE** – RON EPPLEY

There are presently 4 teams from Sun City and 4 teams from Sun City West, and things are going quite well.

A computer has been purchased for the clubhouse to assist in online signups.

Ken also recognized his crew and others who all work hard to keep everything running well. Ken cautioned users of the field and clubhouse to make sure things were closed up after utilization.

Ken also commented on the success of the  $10^{\rm th}$  Annual Cardiac Kids Tournament held February 6, 2016. Through various fundraising aspects of the day, we were successful at raising \$4,000 for Cardiac Research.

# **AMERICAN LEAGUE** – BOB PECK

Bob commented that the American League committee has been expanded to seven members. Bob said that the transition of players between the Central League and the American League has gone very well. The American League will be having a meeting at the field yet this spring for all players to be updated and to have a chance to comment.

#### **CENTRAL LEAGUE** – TED DECAMPO

The Central League is in its second year and has 154 players and 14 teams. All players are assigned. Ted indicated that things are going well in large part to the super group of managers.

# **NATIONAL LEAGUE** – BILL GOLDSPINK

Bill commented that things are going well and that the National League has changed and modified some of their rules, which were approved by the Sun City West Board at the February 1, 2016, Board meeting. The National League is going to survey their members in addition to holding their "Day At the Field" to enhance communications.

#### **WOMEN'S LEAGUE** – CAROL BOWDEN

Carol commented that the Hot Flashes had played in early December and were going to play again this coming Saturday.

Carol also took the opportunity to tell us about Happy Camp, which is an activity sponsored by the Recreation Center and provides the grandchildren of our residents the opportunity to hit a ball, run the bases and thoroughly enjoy themselves. This will happen this year on March 14,21,28.

# **SOFTBALL FIELD IMPROVEMENTS** – ROGER PRIBNOW

Roger discussed the improvements of the dugouts, which were widened by two and a half feet. Roger explained that the board had approved coverings for the uncovered portion of the dugouts. The major ongoing improvements are still in the hands of the Recreational Center, and Larry Griffin has suggested that he will have drawings available next week and that the various inspectors required will also be visiting the site to determine what is needed. Roger said that he would utilize "Batterup," our club newspaper, to keep members informed.

The Tin Cup is still a ways off and the members were encouraged to support this raffle. Dick also commented on the thousands of dollars of prizes that were contributed by our sponsors. Dick also referred us to the eloquent article penned by Hugh Kelly in the Sub City News about the history of the Tin Cup.

# **OLD BUSINESS**

A question came from the crowd as to the status of the batting cage effort initiated last year. President LeMoine indicated that because of elevated costs associated with permitting, the batting cage initiative has died.

A member asked where the new players are coming from and where they are going. Mike Milts suggested that at least for right now, most new players were coming from Sun City and that they were being dispersed in all leagues.

Craig Hone asked the board what was being done with the proposed bylaws changes and suggested that there needed to be some closure since the membership had voted overwhelmingly in favor of them. President LeMoine said that, in a meeting with the Recreation Center, the Club was discouraged from electing committee members. Dick also suggested that the Board has worked hard to rally trust and to make sure everyone was listened to, and he felt that things were going about as well

# Sun City West Softball Board Meeting Palm Ridge Center Acacia Room March 7, 2016 @ 7:30 a.m.

President Dick LeMoine convened the meeting at 7:30 a.m.

Board members present: Dick LeMoine, President, Cal Goings, Vice President, John McFarland, Treasure, Lloyd Styrwoll, Secretary, Marcel Mantha, Larry Reed. Absent: Jim Wille.

Others Present: Lyle Bakken, Jack Gilbert, Ken Skinner, Ted DeCampo, Bill Goldspink, Bob Peck, Roger Pribnow, Carol Bowden, Ron Eppley

Minutes of the February 1, 2016 Board meeting were approved with a motion to approve from Lloyd Styrwoll and a second from Larry Reed. The motion passed unanimously.

Minutes from the February 11, 2016, General Membership meeting were approved with a motion from Lloyd Styrwoll and a second from Marcel Mantha and passed unanimously.

**Treasure's Report** Lyle Bakken presented the monthly treasure's report (see attachment) and explained it in his usual thorough manner. Motion to approve from Marcel Mantha and a second from Cal Goings. The motion passed unanimously.

# **CORRESPONDENCE**

Dick LeMoine received a letter from the REC Center asking for an officer to be present at a mandatory Charted Club Officers Meeting. John McFarland volunteered to attend this meeting on March 30, 2016.

President LeMoine received a concern that the blue paint on our scoreboard was fading. There was a motion by Cal Goings to secure bids on repainting the scoreboard. The motion was seconded by John McFarland and passed unanimously.

There was a concern about not having gates in the dugouts on the field side. After some discussion, no action was taken.

# **COMMITTEE REPORTS**

**BILLBOARDS. BANNERS & TEAM SPONSORS.** Ron Eppley indicated that we have five banners that have not renewed and that Sun City Express has chosen not to renew. Team Sponsors are up-to-date. Arrowhead Cadillac and Desert Golf Cars are both in the process of renewing or procuring a billboard. Outback Steak House is up and may take some additional work to renew.

**UNIFORMS** John McFarland had no report.

**FIELD MAINTENANCE** John McFarland requested that home plate be re-gritted as it was slippery for catchers and that it be painted with a black stripe around the edges for better visibility. Ken Skinner was willing to dedicate this task to John McFarland.

Ken Skinner commented that there are currently 8 events where food is served, and we are adding an additional one on April 9<sup>th</sup>, which will be a double header with the local firefighters. Orie McDonald will be in charge.

Ken said that they had attempted to clean what appeared to be dirt from some of the billboards. What we were seeing was actually fading, and he will be in contact with Debbie Campbell from Fast Signs to see if this could be remediated.

Grass is being cut once a week and is getting long before the next cutting.

The mist system has been serviced in preparation for summer. Hugh Kelly and Ray Early will be involved in a broadcast of a game on Tuesday, March 15<sup>th</sup> on KSCW 103.1 FM, a new Sun City West station. Ken responded to a question about First base, saying that it has been replaced. There was also a concern that the rubber granules in the turf were not being raked in enough.

**SPECIAL EVENTS/FOOD** No Report (Jack had to leave for his game)

**AMERICAN LEAGUE** Bob Peck indicated that players have just been surveyed. They are planning American League membership meeting at

the field on March 15, after the last game. Bob reported that there is no one waiting to be placed, and the American League has a shortage of substitutes. Bob said it has been an excellent session where the competition has been outstanding.

**CENTRAL LEAGUE** Ted DeCampo reported that players have been surveyed to see if they will be playing in summer sessions and next year, and were asked to comment on any concerns they might have. Ted indicated that the session was going very well and that they also had a shortage of subs. Ted said that the Central League's meeting with its members was after the last game today (March 7, 2016). Ted said that he was working with the National League to reorganize and that 30 Central League players could be realigned to the National League, with the top ten having the opportunity to come to the Central League. This would be a net shift of approximately 20 players. Ted asked for board support of this action, which would include a letter explaining this action.

Larry Reed commented on the umpire initiative that is being tested in the Central League. Instead of having two umpires from the team that has previously played, an umpire crew trained by Dan Burke in oneman mechanics has been umpiring most of the games. Larry felt this was going rather well and that, in addition, the Central League was looking at generating a team of scorekeepers to take over that function.

**NATIONAL LEAGUE** Bill Goldspink said that the National League had its membership meeting and that the meeting went very well. Bill indicated that the meetings with the Central League were productive. Bill also said that they were discussing the merits of invoking a minimum standard of ability required to play softball. Bill said that the National League would have five teams for the first summer session, with 55 players and 7 subs.

**WOMEN"S LEAGUE** Carol Bowden reported that the Women will play on Saturday, March 12, 2016, and that they are in then process of scheduling a game in Sun City Grand in April.

Carol also talked about the Hall of Fame Banquet, which is on March 24, 2016. She said that the last day to register would be March 10. She

indicated that there would be two buffet stations. Classic Catering of Peoria would cater the banquet.

Carol is also in charge of Happy Camp, which is March 14, 21, and 28. This Camp teaches skill level softball skills to visiting grandchildren and is sponsored by the Recreation Center. Carol receives assistance from the Reeds, Settjes and Horvaths.

One of the original intentions of the Sun Cities Softball Clubs in forming three leagues was to have three balanced leagues. This would enable an increased number of players to participate without un-balanced schedules, different game days and create a smoother operation.

It is our feeling that the end result of the reorganization will result in a stronger National League as well as a stronger Central League.

#### CENTRAL LEAGUE RULE CHANGES FOR FALL 2016

#### Substitutes -

Roster and Sub players can sub three (3) times per team per sessison. Subs need to be the same rating or lower Roster and Sub players may play four (4) times per week. Limit of two games per day – one team game / one sub game.

#### Drafted Pitchers (In the box at draft time ).

Any pitcher of any rating can sub for drafted pitcher.

Limit two (2) sub games (pitching position) per week – no limit per team.

To Qualify – Team needs to have selected a drafted pitcher out of the Pitcher Box at draft time.

#### Courtesy Runners -

The SSUSA rule on courtesy runners will be used. This means unlimited courtesy runners will be allowed. You may only run once per inning as a courtesy runner. A courtesy runner whose turn at bat comes while they are on base will be out. They will be removed from the base and come to bat. A second courtesy cannot be substituted at this time.

A courtesy runner may not run for an existing courtesy runner except for an incurred injury.

If a player has a courtesy runner he/she can't be a courtesy runner in the same inning.

#### Tie Games -

Home Team will get last at-bats. Visitors will immediately score ½ run to avoid possibility of a tie.

#### Batting Position / Batter's Box

The batter must have at least some portion of both feet on or inside of the lines of the batter's box at the start of the pitch. A batter who steps out of the batter's box at any time during the pitch and then hits the ball fair, or foul, shall be called out. Steps out means touching the ground completely outside of the lines of the batter box.

#### Base Running -

Infield fly rule will be in effect.

Sliding or diving, returning to a base after passing or touching it will be permitted.

#### Commitment Line /Scoring Line -

#### Commitment Line -

Once a runner's foot touches the ground on or past this line, the runner is committed to advancing to the scoring line and may no longer be tagged out.

#### Scoring Line -

A base runner's foot down on or past the scoring line prior to the ball being received by a defensive player touching the strike matt results in the scoring of a run.

#### Crossing or Touching Strike Mat or Batter's Box -

The runner shall be called out if he/she touches or crosses over any portion of the strike matt or the batter's box. Ball remains alive.

#### Umpires and Score Keepers -

Umpires and scorekeepers will be assigned by the CL League umpire and scorekeeping commitee.

Visiting team managers will assign clock operators
