- **4. Wes Horen** and the process to suspend him from any Association function was revisited. A summary was given to the Board outlining the procedure taken; a) Wes was sent a certified letter stating the altered bat issue and requesting his presence at the SCW Softball Board Meeting on Feb 7th. Wes refused delivery of the certified letter on the grounds that it was addressed to "Wes" and not his proper name of "Wesley". Therefore, a Board member contacted Wes and requested his presence at the meeting.
- b) Wes did present himself at the Feb 7th meeting and was given all the time he needed to explain why and how his bat was altered. Wes gave more information as the Board Members questioned him, including; length of time playing, tournaments/play where his bats were determined "altered". Wes surrendered two of his altered bats and stated he would accept any punishment issued.
- c) The SCW Softball Board weighed all the facts and history of Wes altering bats and "A motion was made and passed to recommend that the Sun City West Softball Club recommend to the Sun Cities Softball Association that Wes Horen be permanently

banned from participating in any Association function. And that, notification be reported to all local, state, and regional jurisdictions as well as the ASA.

- d) The SC Sr Softball Association President Wendell Osborne typed a letter and spoke with Wes over the phone as to its contents. Wes told Wendell that it was not necessary to send the letter since he understood. However, Wendell is sending the letter by certified mail to Wesley Horen on March 8th, 2011. A portion of the contents of the letter state; Wes is suspended from play until January 2013. If he chooses to come back and play, his next violation of altered bat will result in a permanent ban.
- e) In the meantime Wes has been contacting Wendell expressing his desire to get his altered bats returned to him.
- f) The SCW Softball Board wants to be sure that the SCW Rec Center and any Local, State, or Regional Jurisdictions as well as the ASA are notified.
- g) ASA is proposing more stringent "Altered Bat Rules". Thus, SCW is incorporating these changes into their rules. These will include and/or add as disallowed; shaving of bats, taping, painting, etc. Exceptions include; "nub grab cones" and/or "friction tape". (Ken Skinner will be working with Wendell for the proper wording).

To be Safe: The Softball Club has permission to have two (2) Charities per year. The Softball Club is a Social Club and it's primary focus is to enjoy

softball. It is not in the business of doing Charities. Therefore, IF more than two Charitable Organizations are being considered then each one must have a Special request submitted to the Recreation Activities Manager for approval.

Recommend Setting up GUIDELINES to follow for Charitable Events

- 1. Always have an Event's Coordinator and present Event proposal to SCW Board.
- 2. Before ANY Event (preferably at the beginning of each year) submit a "Special Request" to the Recreation Activities Manager for approval.
- 3. Only have two (2) Charitable Events per year.
- 4. Do Not co mingle any Club Funds with Charitable Funds.
- 5. Be sure that EVERYONE can participate without fees being charged. You can "Pass the Hat" or players can "Donate". "No" pressure should be put on any club member to make a contribution or donation.
- 6. Once the Guidelines are approved, put in procedure not in Bylaws.
- 7. WHEN IN DOUBT, PICK UP PHONE AND CALL Recreation Activities
