December 31, 2023 Treasurer's Report - Motion Made and seconded and the financial report was approved.

<u>American League</u> - Terry Tichenor said they had six people at the show case yesterday. The draft will be on Monday, January 8th. He will post the list of names at the Club House and the website. Nick Missos made the motion for Terry Tichenor to be the new Chairperson and seconded by Tony Perillo and it was approved. Terry's new committee members are Steve Fedie and Bob Kuhl.

<u>Central League</u> - (Note: Lloyd Styrwoll gave his report after New Business). His new committee members are Dan Burke, Trevor Cornett, Chris Lynch and Steve Engels. They have 10 managers and 10 teams for the Spring session. They approved the tournament bats for the women and they have the right to revoke this decision. Trevor will monitor the bats with a label. The manager meeting is scheduled for today at 10 am. The show case is Tuesday, January 9th and the draft is Wednesday, January 10th. Nick would like to see all three leagues get together and have Standard rules between all 3 leagues. Nick made the motion to approve all three League's Committee Members and seconded by Jack Fischer and it was approved.

<u>National League</u> - Barb Ruzic reported her committee members are Dolly Wolf, Bruce Harte, Jim Hardin, Kevin Schuck and Larry Ott. They have 72 players and 4 subs for the draft on Thursday, January 11th. Donna Reed is training people to be scorekeepers and Bev Burger will have an Umpire clinic.

<u>Women's League</u> - Kay reported the next tournament for the Hot Flashes will be on January 6th and 7th in Casa Grande and they will resume having practices on Thursday afternoons.

70's League - Nick Missos reported the managers have had issues when some of the Saturday games were bumped to Wednesdays, however, they are working it out the best they can.

Field Management - Ken Skinner reported the field is okay. The flag pole cable broke, so the American Flag has not been up. The following tournaments are scheduled; Cardiac Kids on February 3rd, Canadians (if they get enough players) on February 24th, Half-pints vs. Hotflashes on February 25th, CL Spring Fling on March 2nd & 3rd, AL Spring Fling on March 9th 7 10th, and Joint Replacement on March 16th. (Nick asked Al McDuffee to give his report on his new tournament). Al reported that 41 players have signed up and he is working with Daryl Mandrell to raise money for the Shriner's Children's Hospital. Nick Missos will have spare parts - prosthesis on display.

<u>Safety Committee</u> - Terry Tichenor announced that Jim Montgomery will be the American League Safety representative. Nick Missos mentioned the first aid kit should be replenished because there are no big bandaids. Terry will check with the Fire Department on scheduling another AED Training. Terry asked people to stop dropping miscellaneous softballs in the bin. Nick suggested they should have another area for people to donate these softballs that will not be used on the field.

Green Team - Gary Scapito reported 3 new players in December, so a total of 35 new players In 2023. 1 player at a 2 rating and 2 players at a 7 rating. There was 1 player rerated at a 7.

<u>Uniforms & Equipment</u> - Dave Ryg read Ed Prather's attached report. The committee will make a decision on the shorts. The adjustable caps are In and he will hand them out before opening day on January 15th. Desert Embroidery can change the color of jackets to gray and the total cost is \$90.00. He needs to order a couple dozen softballs for the women.

Angels in the Outfield - Kay Peterson read Donna Laufer's report. The 2023 Annual "Pitch In" Toy Drive raised over \$13,000. 21 bicycles, 40 bags of toys and more than \$6,500 in gift cards. They were delivered to Eve's Place, 4 schools, Dysart Community Center and the SCW Women's Club.

Food & Beverage - Dottie Johnson reported that we have raised \$180.00 towards the Hot Dog Wheel. 3 or 4 large blue table cloths are missing and she would like those returned to the Club House. Pizza will be served at the AL Spring Fling and Subway sandwiches served at the CL Spring Fling. Cardiac Kids will have hamburgers.

Hall of Fame Banquet- Nick reported that Jack Ruzic has the contract with Sharko's Catering that needs to be signed for the banquet on March 4th at the Palm Ridge Rec. Ctr. and the Tin Cup dinner on April 7th. Dave Ryg will review and then sign them.

Year end 2023, we earned income of \$405.87 on our CD's and BMO Money Market. Motion Made made by Kay Peterson to approve the January 30, 2024 Treasurer's Report and was seconded by Larry Reed and the financial report was approved.

#### <u>American League</u> - Terry Tichenor said there was nothing to report.

#### Central League - Tony read Lloyd Styrwoll's following report;

The Central League has played seven games this Spring session and has been fortunate to avoid the rain and the frost. We have worked diligently on changing a number of our rules to align with SSUSA rules and had planned to bring them to you for your approval, but after meeting with the other Leagues and Larry Reed, we have decided to wait until our rules and policies are complete before we seek your approval. #### **Green Team Policies and Procedures**

#### March 23, 2024

#### Amendment 1

- GT P & P has established a procedure for the re-rating of returning players.
- GT P & P has been updated to include additional responsibilities required by the Green Team Coordinator.

Amendment 1 is now part of the Green Team Policies and Procedures dated November 8, 2023.

#### Returning Player Re-Rate Procedure:

Reference:

- American League rule: Section (H). Responsibilities of Players.
- Central League rule: Section (14). Responsibilities of Players.
- National League rule: Under review.

To highlight the club rules referenced above for each league, any player who has been absent for 1 year or longer for any reason shall be required to attend a Green Team tryout for their re-rate. Amendment 1 will add a procedure for a returning player re-rate through the Green Team process.

Each league Chairperson shall be responsible for determining that a player has been absent for one year or longer. This will be facilitated by the league Chairperson from the last league the player had participated in. The returning player re-rate results from the Green Team will then establish which league the player will now enter.

Note: Summer ball player re-rate may be excluded at the discretion of the league Chairperson.

Note: A returning player re-rate session will only be available when there is an established Green Team scheduled for a new player rating session.

## Green Team Policies and Procedures

November 8, 2023

#### Softball Club Mission Statement:

The Sun City West Softball club main objective is to promote and welcome new players to the club regardless of a players skill level and abilities. The Green Team program's main objective is to evaluate all new players entering into the softball club. New players receive a league rating which enters the player into the appropriate league based on the players skill level and abilities.

#### Green Team Coordinator Responsibilities:

- Receive initial contact from a new player via phone call, email, text, field visit, etc.
- Issue new player welcome package via email, club website or at the field.
- Request a sports bio from the new player to assist with the Raters evaluation.
- Establish the Green Team tryout scheduling date and publish on the club website.
- Coordinate with the lead Rater in scheduling the Green Team session & Rater selection.
- Collect softball league membership dues including new player waiver form.
- Orchestrate the Green Team field tryout session.
- Meet with the lead Rater to discuss the new player final rating results.
- Coordinate new player uniforms issued by the league Uniform Manager.
- Discuss rating with new player and issue an exit document for registration process.
- Publish Green Team rating results to AL, CL & NL leagues committee chairs and officials.
- Publish the Green Team rating results on the club website.
- Guide & assist the new player through the Sports Engine registration process.
- Guide & assist the new player through the league registration process.
- Notify treasurer that all new members have paid their dues and have completed their Sports Engine registration process.

#### Policies:

Each league shall furnish approved Raters for the Green Team rating session. This ensures the availability of Raters from each league maintaining a sufficient Rater pool representing the American, Central & the National leagues as a 3-league club. The approved Raters shall be rotated at any given session allowing rater diversity for each rating session.

### Procedures:

## League Rater Representation format:

A total of 5 approved Raters will be required to ensure a tie breaker if needed. At least one league representative will be required at all Green Team rating sessions to achieve a balanced ratio of Raters from the American, Central, & National leagues.

The league Rater representation shall allow for a Rater alternate within the combination of the 5 Raters at the discretion of the Green Team Coordinator.

Note: In the event the correct ratio of Raters was unable to be coordinated due to Rater seasonal scheduling or other unforeseen circumstances, a modified Rater session may be required to accomplish the Green Team program objective at the discretion of the Green Team Coordinator.

- The Green Team Coordinator shall not be an assigned Rater. If an unexpected absence occurs, the remaining Raters (less than 5) will be authorized to rate based on this isolated situation. This will be at the discretion of the Green Team Coordinator.
- The Green Team Coordinator shall approve all Green Team Raters.

Discretionary Objective: In the event of a conflict of a new players unavailability to play on a specific league schedule due to a work schedule or personal commitment, the Raters for that particular rating session will evaluate the new player's circumstances and merit on a case-bycase basis.

Actual Case Example: A new player is issued a 3 rating for the AL and is unable to play the AL schedule due to personal circumstances. If the player was only available to play the CL schedule, the Raters would evaluate the specific situation and only the Raters will make the final determination by allowing a revised rating to accommodate a new players schedule. Therefore, the player rating may be revised from a 3 to a 4 rating at the discretion of the Raters allowing the individual to play in the league.

It should be noted: It has been widely accepted that 3 and 4 rated players are considered interchangeable between the AL and the CL leagues. Also note: If a new player was issued a higher rating of a 1 or 2, the above case example would not be authorized to be revised to a 4 rating to accommodate a new player's schedule. This would also apply to the CL vs NL league as well and evaluated on a case-by-case basis by the Raters.

The Green Team Raters are the **Only Authorized Club Entity** to rate new players which shall include the re-rating of a returning player.



## Amendment 2.

- GT P & P has established a procedure to incorporate the new player 9B rating criteria.
- GT P & P has established term limit guidelines for the GT Program Coordinator.

Amendment 2 is now part of the Green Team Policies and Procedures dated November 8, 2023.

## Incorporation of the New Player 9B Rating:

All new players who wish to join the Sun City West softball club are required to attend the Green Team tryout process *regardless* of their softball skills & abilities. This includes all returning players who have been absent from the softball league for 1 year or longer (Ref. Amendment 1, dated March 23, 2024).

Upon the completion of the new players tryout, the player will be issued an official league rating of 1 through 9. However, if a players skill level has been determined to be a 9B rating by the Green Team Raters, the player will be required to enter into the National League Instructional Clinic prior to entering on a National League team assignment. Note: This program will be under the National League guidance.

It should be noted: New players will be advised **prior** to attending the Green Team tryout, that if their rating has been established as a 9B rating, they will be required to enter into the National League Instructional Clinic.

## Green Team Coordinator Term Limits:

As with many internal club term limit structures, the GT Coordinator shall have an established 2-year term limit. However, upon the conclusion of this tenure, the Softball Board shall have a vote of approval to the extension of the GT Coordinators term by 1-year optional increments at the discretion of the Softball Board. This vote shall take place within the month of December of each year after the initial 2-year term has expired. When a new GT Coordinator has been approved by the Softball Board, there will be a 30-day transition phase to the successor GT Coordinator. January 1<sup>st</sup> will begin the term for the new GT Coordinator.

Comments:

As of September 9, 2024 we have 325 paid members of which 307 will play in games and 18 are non playing club members. The total number of club members translates in to \$16,250 annually for income from dues. We also generate income from team sponsors, bill board sponsors and the sale of club gear such as T Shirts and jackets.

I called our contact with the IRS on Friday (9/06/24) but have not received a call back to check on the status of our Tax Code.

The club is officially part of Club Track with a scanner that is located in the lower level club house. We will get a monthly report showing how many club members and guests have utilized the ball field. The report will show the number of distinct club members (individual club members based on their Rec. Card Number) and Total Check-ins which shows the number of times the club member scans in during a month as well as guests. Keep in mind, guests do not play games nor are charged to sit in the bleachers to watch games.

With the change from Sports Engine to Team Sideline, a question was raised in regard to what we pay World Pay and Authorized.net for income received via credit cards. For minimum transactions through World Pay, we pay \$30 per month and \$.10 per transactions. For Authorized .net we pay \$7 per month and \$.04 per transaction. So far in 2024, we have received credit card payments for annual dues and payments for the Tin Cup totaling \$15,760 and we paid the credit card services \$1,181 which is 7.5% of the total dollars received.

The annual fee to use Team Sideline was \$618. Last year we paid Sports Engine \$643.

Since the first of June, expenses have been lower. We replaced the stolen camera and equipment that totaled \$733. We have a sponsor that wants to pay for that cost plus annual dues that is yet to be determined. We did pay a bit more this summer for water and Gatorade due to the high temperatures during all three summer sessions. We will be ordering 11" and 12" balls and getting some additional caps. Supplies for the Welcome Back have been purchased as well.

# "Minor/AAA" League for the SCW Softball Club

The Minor/AAA League is for anyone that is interested in playing softball or reacquainting themselves to the game. This league is designed for residents that are interested in playing softball, who are new to the game or who would like to work on their skills or who have a 9B rating.

If you are new to softball, residents must complete the SCW Softball Club Green Team process and receive an appropriate rating based on your skills. If you receive a 9B rating, you will be required to participate in the Minor/AAA League. It is in this Minor/AAA league that you will learn the fundamentals to playing softball. You will have the option to attend clinics hosted by well-experienced players from the Sun City West Softball Club.
