A motion was made by Rich Wells and seconded by Rich McAndrews to retain Lyle Bakken as the club's financial consultant. Motion carried. Lyle Bakken states that the Rec Center has agreed to the 50/50 revenue arrangement between the Sun City West Softball Club and the Rec Center. Also, there will be a workshop on January 9th at 9 a.m. with the Rec Board at the Lecture Hall. The club membership at the present time stands at 321.

CORRESPONDENCE:

Herb Clark reminds the board of the upcoming Vintage Baseball Tournament on January 17th & 18th. The Board supports the Vintage program; and it was decided that all monies taken in by Vintage activities will go to the Club to cover expenses, and should there be any excess funds, that balance will go to the Vintage Baseball program.

FIELD MAINTENENCE:

A motion is made by Rich Wells that George Karras be retained as Field Maintenance Director, and the board supported the motion unanimously. George states that the new Ramada project has been delayed, inasmuch as the county wants a civil engineer to review the project. Sun City Awning has already been retained to install the project. George goes on to say that the Mister Project is on course, and installation will begin soon.

The project regarding a new sound system is not progressing at all and is still on hold. George states that on those days where the field is not suitable for play that he will notify the League President, who will in turn notify the managers of the first scheduled game of the cancellation, and who will in turn notify the managers of the next subsequent game, and that process will continue until all managers have been notified.

SPECIAL EVENTS;

- (1) Tin Cup. Dick Lemoine tells the Board that with the slumping economy the Annual Event known as the Tin Cup may take on a whole new direction thru downscaling and restructuring. Dick feels that by downscaling, the tournament activities, to include golf and food, could be done somewhere in the range of \$50 per person. Dick went on to emphasize the importance of involving the sponsors in the event. The sponsors will pay their own green fees. The tournament is scheduled for March 29, 2009.
- (2) Day In The Park. This sponsor day is scheduled for March 14, 2009 at Liberty Field, and it is felt that this event is exceedingly important to maintain good Sponsor/Club member relations.
- (3) Tournaments Cardiac Kids Ken Skinner

 The tournament is scheduled for Feb.7^{th,} and the festivities could include a golf car parade. The tournament has been renamed to the *Bill Bromley Cardiac Kids' Tournament*, and special hats will be designed with Bill's initials and beginning date on the hats. A motion to absorbing the costs for the caps, renaming the tournament, and absorbing the costs for burgers, etc., was made and approved unanimously.
- (4) Bosom Buddies Ken Skinner
 The Tournament is gathering progress, and the Board voted in favor of picking up the expenses of the tournament.
- (5) Spring Fling. American League and National League reps will promote this tournament and seek sign-ups. March 1st is the targeted

date of the event. Rich McAndrews and Ken Skinner will be the contact persons.

BILLBOARDS – Carol Bowden

A letter of thanks has gone out to all billboard sponsors, and Carol and Chuck Hendrix will make personal contact with all sponsors.

NEW BUSINESS

A season-ending game will be scheduled for April 11th as planned with the American League 1's & 2's competing against each other, and 3's & 4's likewise competing. The National League will have a like-type competition.

Rich Wells states that an account has been established with Basha's for doughnuts at Liberty Field on game days.

The issue of women's dues has again come up, and this matter has to be resolved at the League level.

Rick Fish states that he is organizing a men's/women's team called the X-Caliber. Rich asks that the Club recognize the club as a Sun City West Tournament team and asks that they be allowed to schedule field time. Team members will pay for all equipment/uniforms, etc. A motion was made by Rich Wells to grant this request and seconded by Carol Bowden; the motion carried unanimously.

*CORRECTED MINUTES

The meeting was called to order by President Rich McAndrews and Roll Call was taken of Board members. Present were: Rich McAndrews, Rich Wells, Jan Strock, Chuck Hendrix, Carol Bowden, *Bob Williams and Joe Oliver.

Guests: Herb Clark, Laurel Andrew, Ken Skinner, Lyle Bakken

A motion to accept the minutes for January 2009 was made and accepted.

TREASURER'S REPORT; Lyle Bakken

Lyle submitted the following accounts, and a motion was made by Carol Bowden to accept; seconded by Rich Wells.

Rich McAndrews did a quick review of the month of January and stated that it is imperative that any injury occurring at the ball field must be documented as quickly as possible and turned over to the monitor at the swimming pool for forwarding. Rich went on to say that the sock issue had been addressed by the League Board, and it was decided that players may wear white ankle/knee socks if they

so choose. However, the League will pick up the costs for only the League issued socks. The Rec Board voted on and approved the 50/50 arrangement, whereby the SCW Softball Club would receive 50% of Billboard Advertising monies and the Rec Center would receive the remaining 50%. Rich McAndrews added that sincere thanks should be given to Rec Board members for their support.

It was stated by Rich McAndrews that any non-club member wishing to practice on the field needed to schedule time with George Karras's approval, and that a liability waiver had to be on record. It was further stated that when an application was received, it would in turn be forwarded to Ken Skinner, who would enter that applicant into the data bank

CORRESPONDENCE: Rich McAndrews received a letter from a resident, whose property is proximate to our right field fence, regarding the frequency of balls coming onto his property. Rich will meet with the resident; but in addition, George Karras will look into the costs of a fencing mesh surrounding the outfield areas.

COMMITTEE REPORTS;

Laurel Andrews states that the women's league is functioning well. George Karras was not present, but Rich McAndrews stated that he had been told by George that the Misters are currently being installed, and that he wished to extend his thanks to Herb Clark for his assistance. It was further said that the current Ramada in the process of construction has been modified to a picnic-like table with handicap accessibility.

TIN CUP: Dick Lemoine

Rich McAndrews states that the annual tournament currently referred to as the "paper cup" is still scheduled for March 29th and that the Palm Ridge hall and Deer Valley Golf Course have both been reserved for that date. No further information available.

BILL BROMLEY MEMORIAL CARDIAC KIDS TOURNAMENT; Ken Skinner

Ken reports that the tournament is scheduled for February 7, 2009 and will begin with a golf car parade, starting from the Sundome at 8:30 a.m. and proceeding to Liberty Field, where the games will begin at approximately 9:00 a.m. The tournament will consist of four teams that will play two games each. The tournament is expected to wind up at approximately 3:00 p.m. Refreshments will be available at the field. All proceeds will go to the Arizona Heart Foundation.

BOSOM BUDDIES; Ken Skinner

The event is a club-sponsored event scheduled for February 14th & 15th. There are six (6) games scheduled for this event.

SPRING FLING: This American/National League event is scheduled for February 26th, 27th and 28th. *Bob Williams tells us that the Spring Fling will have 12 teams this year the most ever, playing six games on Feb26th and six games Feb 27th.Food, drink and awards will be part of the festivities.

PALM DESERT TOURNAMENT: This annual event is scheduled for April 25th, and there will be two teams each, consisting of 60-yr. and 70-year-old players.

DAY IN THE PARK

This annual sponsor-appreciation event is scheduled for March 14th, and necessary tables and chairs have already been requested. This is an important event in order to maintain a close relationship between the Clubs and the sponsors.

SEASON ENDING SOFTBALL DAY;

This event is scheduled for April 11th and will be made up of teams from the American League, ratings 1-4.

UNIFORMS:

Carol Bowden showed a new type of women's athletic shorts that will be more user friendly than the current style. The SCW Board unanimously approved the shorts and furthered the matter to the League Board for final approval

CORRESPONDENCE:

COMMITTEE REPORTS: Laurel Andrew

Laurel had nothing new to relate concerning the Women's League but did remind the board of the upcoming Cancer Survivor Day March 7th. The event will begin with a walking event, with a \$5 entry/donation, beginning at 7:30am, followed by a softball game at 9:30am.

FIELD MAINTENANCE:

The new field misters are ready to go and will be ready for Day In The Park. Paving stones will soon be laid for the new Ramada area. Rich McAndrews stated that he had met with the local resident who had been experiencing balls landing in his yard. The possibility of screening being put up was discussed. However, nothing final has been determined or approved. It was further mentioned that those individuals using the field along with a batting tee must hit from the area of home plate, and not to use any portion of the fencing as a backstop for the ball.

SPECIAL EVENTS:

CANCER SURVIVOR DAY-

Ken Skinner did a brief follow-up on this event, mentioned earlier in the minutes, and the Board elected to purchase four (4) \$25 gift certificates for Rosie's Italian Restaurant. Raffle tickets for the gift certificates will be drawn at the event on Saturday, March 7th.

DAY IN THE PARK:

Joe Oliver told the Board that he had sent out 62 letters inviting and reminding sponsors and advertisers about the upcoming Day In The Park on March 14, and asking that they participate. It is estimated that approximately 1,000 people will participate in the event. Rich Wells will coordinate the setting up of the event, i.e., tables/refreshments, etc., and his group will begin about 7:00am. All those ball players serving as workers or as just attendees are asked to wear their game jerseys. Carol Bowden told the Board that the Daily News-Sun and the Independent Newspapers, promoting the Day In The Park, would run special ads. Chuck Hendrix will be putting together signboards advertising in various parts of the city. Carol Bowden states that the Posse will handle traffic control. A motion was made by Rich

Wells and seconded by Rich McAndrews that, instead of sponsors just receiving the traditional pictures, they receive small plaques of recognition for display. The motion was passed unanimously. Rich McAndrews stated that he, personally, would contact the sponsors concerning Day In The Park and the Tin Cup golf tournament.

TEAM PICTURES: Carol Bowden

The team pictures are scheduled for March 17th and March 19th at Liberty Field and, as mentioned earlier, plaques with the Sun Cities logo will be given to sponsors for a cost of \$30 per plaque, paid for by the club.

LEAGUE BANQUET: Carol Bowden

NEW BUSINESS; Rich Wells

Rich reports that there are 30 members who have no liability waiver on file. Bob Williams will follow up on this for the National League and Rich Wells will do likewise for the American League. Ken Skinner suggests that we adopt a smaller waiver type card. This will be further discussed at the April meeting. The Board stated unanimously that all guests must sign a waiver before using the field.

Ken Skinner briefly discussed the potential of having an online camera security system, which would allow the observation of the field during non-use time.

Ken also spoke to the Bosom Buddies' event, which took in \$23,000.00 for the Breast Cancer Fund. The Spring Fling was discussed, and Bob Williams indicated that 12 teams from the National League would be playing, and that the dates of the Spring Fling would be Feb.25th –Feb. 28th.
