

WWTPC Pickleball League Policies & Procedures

- I. General.
 - a. This document serves as general policies and procedures for the WWTPC Pickleball League.
 - b. WWTPC Staff reserves the right to add, delete, or amend these policies & procedures at any time as they see necessary.
- II. Divisions
 - a. 3.0-3.5 - This division is for advanced beginner to intermediate level players who understand the game, have basic strategy concepts, and developing shot control.
 - b. 3.5+ - This division is for intermediate to advanced level players who have consistent shot control, understand hard vs soft game, and tactical awareness.
- III. Schedule
 - a. Tuesday Evening Matches:
 - i. Women's: 3.0-3.5 & 3.5+ (7:00PM – 8:30PM)
 - ii. Mixed: 3.0-3.5 (8:30PM – 10:00PM)
 - b. Thursday Evening Matches:
 - i. Mixed: 3.5+ (7:00PM – 8:30PM)
 - ii. Men's: 3.0-3.5 & 3.5+ (8:30PM – 10:00PM)
 - c. First match of the regular season for Tuesday Night divisions.
 - i. Summer 2026: June 9th, 2026.
 - d. First match of the regular season for Thursday Night divisions.
 - i. Summer 2026: June 11th, 2026.
 - e. The dates for playoffs are listed below;
 - i. Summer 2026 each beginning at 7:00pm: Divisions will be assigned to each date once registrations are finalized and confirmed.
 1. Tuesday, August 4th
 2. Thursday, August 6th
 3. Tuesday, August 11th
 4. Thursday, August 13th
 - f. Schedules will be posted on [Teamsideline.com/Coppell](https://www.teamsideline.com/Coppell) under each division.
 - i. Teams will play two matches each week; either in the first two time slots (7:00pm & 7:45pm) or in the last two time slots (8:30pm & 9:15pm)
 1. Courts will not be available prior to 7:00pm unless your team reserves the court and pays the appropriate fees.
 2. Teams will have 15 minutes to warm up prior to their first match beginning at 7:00pm or beginning at 8:30pm.
- IV. Registration
 - a. The fee is PER PERSON

- i. Resident = \$30
 - ii. Non-Resident = \$45
 - b. Each player will register individually through Active Net – www.coppellactivities.com.
 - c. Registration will CLOSE at 11:59PM on SUNDAY, May 31st
 - d. Teams will be able to add players through **the second match day of the regular season.**
 - i. If a captain needs to remove a player, contact WWTPC Staff at wwtpc@coppelltx.gov
 - e. WWTPC Staff may move a team or player to another division based on their performance in past seasons.
 - f. Each division is set to hold 8 teams each, however WWTPC Staff reserves the right to combine/expand divisions as they see fit to optimize the league format.
 - i. The first 8 teams to register will guarantee their spot in the league, teams that register after the first 8 will be on the waitlist.
 - 1. A team is confirmed as registered when at least 2 players have registered under the same team name.**
 - g. Waitlisted teams will be registered if a space is available.
 - h. The registration deadline for the Summer 2026 season is February 22nd, 2026
 - i. Refunds for withdraws will go as follows.
 - 1. Withdraw before: JUNE 5th = 100% REFUND
 - 2. Withdraw before: JUNE 22nd = 50% REFUND
 - 3. Withdraw after: JUNE 22nd = NO REFUND
- V. Defaults and Retired Matches
- a. If you know your team cannot make a match, please send WWTPC Staff an email (wwtpc@coppelltx.gov) by 12:00PM the day of the match notifying them.
 - i. These matches can be rescheduled at a date and time agreed upon by both teams prior to the playoffs. If the match is NOT played prior to the playoffs it will result in a forfeit by the original absent team.
 - ii. If the scheduled matches are cancelled due to WWTPC closing or weather, and a team had notified staff about being absent; these matches may be made-up according to section VI “Rescheduled Matches” in the Rulebook.
 - b. No-Shows: If a team has not arrived by 15 minutes after the scheduled match start time, inform WWTPC staff at the front desk. The absent team will forfeit the match.
 - i. If the absent team has players competing in a division that is playing in the earlier timeslot of the same evening, and their matches have not completed; they will be allowed to finish their match and report to their next court immediately after.
 - c. Teams that NO-SHOW for **TWO match nights** during the regular season will be removed from the pickleball league. A refund will NOT be processed.
 - d. Teams that FORFEIT more than **4 matches** during the season may be disqualified from the pickleball league playoffs.
